## *Spay / Neuter Contract*

### **SPAY/NEUTER CONTRACT**

Seller agrees to sell and Buyer agrees to purchase a companion puppy subject to the following terms. Seller warrants that the above described puppy/dog is a purebred Basset Hound and that the application for limited AKC registration has been shown to the Buyer as of the date of the completed purchase but said limited AKC paper work will be withheld until Seller/Breeder receives proof of Spay/neuter as described below.

Buyer agrees that the puppy/dog described above must be spayed or neutered before the age of 9 months from the date of birth. Buyer must then send a copy of the vet's report along with photos of the dog. Proof must be received by Seller before dog is 10 months old. After receiving proof of spay/neuter from a licensed Veterinarian in writing, we will mail you your registration paperwork. Breeder reserves the right verify the procedure with the vet. Buyer agrees not to breed the above-described puppy/dog at any time. If the Buyer breeds the puppy/dog, without express written permission of the Breeder, the Breeder has all rights to take back the ownership of the dog and any puppies produced will revert back to the Breeder and you shall pay a fee of \$1000 for breach of contract, plus the cost of any veterinary care needed due to the dog being bred. Buyer will not be compensated in any way for dam or the puppies, nor will be Buyer be due any type of registration papers whatsoever then or in the future.

This contract states that the dog listed herein is being sold on a limited registration. This means that the pup will be altered (spayed or neutered) and that it will not, in any way, be used for the purposes of breeding.

By signing this agreement you are acknowledging that If you are found to have bred the dog in question at any time without written approval from the Breeder, ownership of the dog and any puppies produced will revert back to the Breeder and you shall pay a fee of \$1000 for breach of contract, plus the cost of any veterinary care needed due to the dog being bred. Again, all paperwork and veterinary records shall be provided as well.
